The Aurellan Global Shares Fund and Aurellan Hedged Global Shares Fund both invest in diversified portfolios of global shares managed using a manager-of-managers approach. Aurellan has a partnership with Wilshire, who are experts in researching global investment managers and constructing portfolios. The current underlying investment managers of the funds are Loomis Sayles, Los Angeles Capital and Causeway Capital. The Aurellan Global Shares Fund is unhedged and the Aurellan Hedged Global Shares Fund targets to be fully hedged to New Zealand dollars.

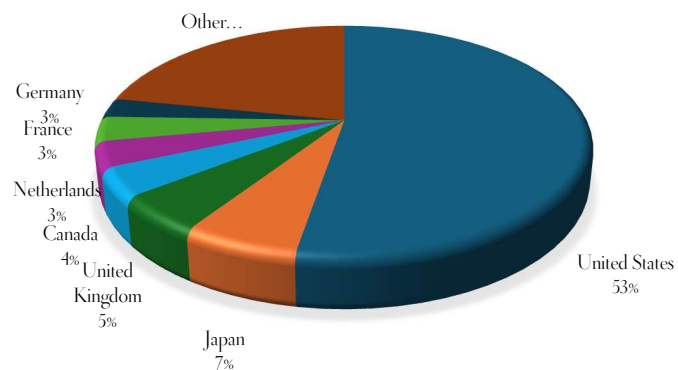
